Mr. Hannah currently is a Senior Fellow at The Foundation for Defense of Democracies, where he writes and speaks on US foreign policy. His articles have been

published in The New York Times, Washington Post, and Wall Street Journal, and he blogs regularly at ForeignPolicy.com. Mr. Hannah is a graduate of the Yale Law School and Duke University.
