### **FORMER SINGAPORE POLICE CHIEF AND PRESIDENT OF INTERPOL JOINS ARCANUM AS SENIOR ADVISOR**

Mr. Khoo was Commissioner of the Singapore Police Force from 1997 to 2010 and from 2008 to 2012, he was the President of INTERPOL, following his post at the international organization as Vice President for Asia from 2006 to 2008.

Vice-Chairman of Arcanum and former Director-General of the UK National Crime Agency, Keith Bristow, who has worked with Mr. Khoo for many years stated, “I admire and respect his huge personal contribution to law enforcement through a long and distinguished career. For his contribution to the police service, he was awarded the Public Administration Medal (Silver) in 1992, the Long Service Medal in 1998, and the Meritorious Service Medal in 2003 by The President of Singapore.
